Non-Resident Fishing: The HOA Board submitted the appropriate paperwork to



the Eagle Police Department authorizing them to ticket trespassers fishing on Island Woods property. Homeowners can approach potential trespassers asking them for their home address. That's the easiest way to differentiate between a homeowner or trespasser. If they are indeed trespassing, homeowners can tell them they are calling the police to report them, and they will be ticketed. To report trespassers Homeowners can contact the Eagle Police Department's non-emergent dispatch number: (970) 479-2200. If the trespasser has a vehicle parked nearby be prepared to provide the license plate number to the Police.

Solicitors: Homeowners, did you know, because Island Woods has signs at both entrances stating, "No Soliciting", it is against the law for solicitors to go door to door on this property. To report a solicitor trespassing contact the Eagle Police Department via their non-emergent dispatch number (970) 479-2200 to make a report. If possible, provide the solicitor's City issued license number that they are required by law to have with them.

Mosquitos: Tis the season of the bite. Having issues with mosquitoes contact the Ada County Weed, Pest & Mosquito Abatement Office (208) 577-4646 or access their office information on the Ada County website, adacounty.id.gov under departments to submit an Adulticide Service Request Form for treatment services.
