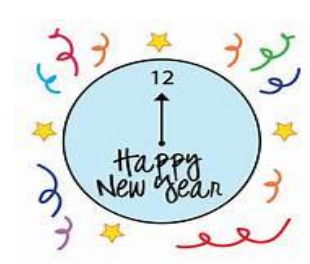

The Annual Member's Meeting:

The agenda for the meeting is a 2023 year-end financial review, the approved 2024 budget, IWHOA Project Team update and the 2024 Board of Directors vote.



All 2024 Board of Director nominations have been sent to the Board Nominating Committee, Jill Barbour, Sharleen Olsen and Jim Brostmeyer. Due to holiday travel,

the Committee was unable to conduct interviews prior to the newsletter submission deadline, so the Board Nomination Committee's Board nominees will be announced prior to the Annual Member's Meeting via email to homeowners.

The ballot used at the Annual Member's Meeting for voting in the 2024 Board of Directors does allow write-ins for Board nominees from the floor.

A proxy is enclosed with this newsletter for homeowners unable to attend the annual meeting. If you appoint the Secretary as your representative to vote on your behalf the Secretary votes for the three candidates nominated by the Nominating Committee. If you want someone else to vote for you, print the representative's name on the proxy and have them bring your proxy to the meeting. A ballot will be given to your representative to register your vote at the Annual Meeting. **Please note proxy submission deadlines notated on the bottom of the proxy form.**

Unofficial results of the 2024 Board of Directors vote will be shared with homeowners prior to meeting adjournment. The official results will be emailed out to homeowners once all votes have been compared to the Homeowner's List, provided by the accountant, and votes are confirmed to be one per household.
